CHIEF LAW OFFICER

Chief Law Officer will report to Chief Executive Officer IESCO Limited and shall manage and oversee IESCO's legal department and shall be responsible for dealing with Legal, Litigation, Labour, Services, Corporate and Regulatory affairs of the Company.

1. RESPONSIBILITIES:

- Overall responsible for legal matters of IESCO Limited.
- Review, Improve and Develop IESCO's Legal Policies & processes.
- Provide legal services and support to all Departments of the IESCO Limited.
- Manage and Overseas all litigation cases including Corporate, Constitutional, Civil, Service and Criminal matters of the company.
- Render Legal Opinion to Board of Directors, CEO and management of IESCO Limited on multifarious matters pertaining to Tariff, Service, Labour, Civil, Corporate, Criminal, Banking and Energy Sector etc., including vetting and drafting of legal documents and agreements.
