The broad job description of legal advisors is detailed below:

- Placing and defending civil suits/cases for and against LDA in various courts of law;
- Filing of appeals against orders/decrees for and against LDA in Appellate Courts;
- Vetting of contracts/agreements;
- Assistance in legal issues pertaining to execution of contracts/agreements;
- Provide legal advice on day to day legal issues and financial aspects;
- Any other legal proposition related to other official matters.

The appointment criteria for hiring of legal advisors is as under:

1.	Senior Legal Advisor (for Supreme Court)	02	Advocate (LLB or Bar-at-law) with minimum 5-years' professional experience as advocate Supreme Court, and 20-years' as advocate Civil Courts. The candidates having higher qualification and relevant experience shall be preferred.
2.	Senior Legal Advisor (for High Courts)	04	Advocate (LLB or Bar-at-law) with minimum 10-years' professional experience as advocate High Court, and 12-years' as advocate Civil Courts. The candidates having higher qualification and relevant experience shall be preferred.
3.	Legal Advisor (for Civil Courts)	02	Advocate (LLB or Bar-at-law) with minimum 07-years' professional experience as advocate High Court, and 15-years' as advocate Civil Courts. The candidates having higher qualification and relevant experience shall be preferred.
4.	Assistant Legal Advisors (for Civil Courts)	20	Advocate (LLB or Bar-at-law) with minimum 05- years' professional experience as advocate High Court, and 10 years' as advocate Civil Court. The candidates having higher qualification and relevant experience shall be preferred.

- Attested copies of License from Punjab Bar Council, High Court Bar Council, and Supreme Court Bar Council should be attached, where applicable.
- In addition to active practice, the candidates must have in-depth knowledge of Land Laws, Service Matters, Labor Laws, Corporate, & Civil Laws, and financial issues involved in such matters.
